# Frank Emory Charlotte Chamber By: Jim Kelley

Natalie English with the Charlotte Chamber introduced our program - Frank Emory, the current Board Chair of the Charlotte Chamber. Frank



was born in Wilson, NC and attended Duke University as a Duke Scholar where he was President of the Student Council. From there he attended law school at UNC Chapel Hill. Currently Frank is a partner with Hunton and Williams where his practice focuses on complex commercial litigation and arbitration. During his nearly three decades in practice, he has tried more than 60 cases in state and federal courts and before arbitration panels and administrative

agencies. Frank is on the Board of Trustees and Executive Committee at Duke University. He is a former President of the Mecklenburg County Bar and is a recipient of the Long Leaf Pine, North Carolina's highest civilian order.

Frank emphasized early on in his presentation that the Chamber takes no public funding but is funded 50% by membership dues and 50% by a members campaign. The Chamber has 3,300 members – 80% of which have fewer than 100 employees. Its mission is to grow the economy, provide innovative programs and support pro business public policies.

Programmatically there are three focuses – member engagement, public policy and economic development. In the area of member

engagement, the Chamber wants to help its members network with each other, provide good content through its events and programs and help support the business community. There are seven chapters in Charlotte – Ballantyne, East, Metro, Northwest, South Park, Southwest, and University City. The Chamber provides over 100 events a year for it members and has special focuses on entrepreneurs, affinity chambers and minority enterprises.

In the area of public policy, the chamber focuses on business friendly policies on a local, state and federal level. On a state level, there is gavel to gavel coverage through a lobbying firm. On a federal level, there are several visits each year to Washington, DC. The Chamber hosts several summits each year. In 2012, there have been or will be summits in the following areas – transportation, an entrepreneurial ecosystem, role of creativity and innovation, healthcare and workforce. There are several focused public policy committees including aviation, land use, transportation, legislative, workforce issues and workforce development.

In the area of economic development, the chamber staff has a combined 115 years experience. They focus on recruitment, research, retention and redevelopment. They target special sectors including transportation, tourism, manufacturing and foreign firms. There are over 600 foreign firms in Charlotte and over 200 of those with ties to Europe.

In closing, Frank discussed some recent highlights. In 2012, the Chamber assisted with over 3,000 jobs and had over 100 client visits. In the past ten years, the Chamber has recruited 6,790 new companies to Charlotte, helped

create 56,338 new jobs and brought in \$11 billion in investments. What a difference the Chamber makes for our community.
