JUSTICE MARK A. DAVIS A Brief History of the North Carolina Supreme Court

In keeping with the judicial theme of the day, John Tabor used his allotted Health and Happiness time to share a succinct, yet highly informative, history of the United States Supreme Court. Justice Mark Davis followed up with an in-depth synopsis of the North Carolina Supreme Court, with a focus on the machinations and impact of the Court during the period from 1986-1995.

Justice Mark A. Davis, a Fayetteville native and graduate of UNC Chapel Hill (both undergraduate and law school)

and Duke University (LLM), was named Associate Justice of the North Carolina Supreme Court by Governor Roy Cooper on March 11, 2019. Prior to that, he served as an Associate Judge on the North Carolina Court of Appeals, was a Special Deputy Attorney General in the North Carolina Department of Justice and was in private practice with Womble Carlyle Sandridge & Rice. He also served as a law clerk to the Honorable Franklin T. Dupree, Jr. in the United States District Court for the Eastern District of North Carolina and was General Counsel in the Office of the Governor for two years. Justice Davis is the author of a recently published book, A Warren Court of Our Own: The Exum Court and the Expansion of Individual Rights in North Carolina.

What began as his graduate thesis for the LLM program at Duke quickly morphed into much more. While serving on the North Carolina Court of Appeals, Justice Davis noted that many of the cases cited in matters before him were decided during the period 1986-1995. The Supreme Court at that time was largely Democrats, led by Chief Justice James Gooden Exum, Jr. Davis describes Exum and his fellow Justices as "luminaries," large personalities prone to spirited philosophical debates which were liberally sprinkled throughout the written opinions of the Court. Under Exum's leadership, the North Carolina Supreme Court expanded civil rights, reconsidered existing criminal justice procedures and increased available remedies in torts law. He likens these impacts to the Warren Court of the 1950s and 60s, an era in which the decisions of the Judiciary resulted in significant changes in constitutional law, particularly

in the areas of race relations and criminal procedure.

Although focused on the findings of the North Carolina Supreme Court during a specific time frame, Justice Davis also shared the history of the Court since its inception in 1799. Given recent events in the United States Supreme Court, we could all benefit from the historical context of our Judiciary, both local and national. Time to add Justice Davis' book to your reading list!
